3. Implementation


- Enabled and configured Microsoft Defender for Office 365, Endpoint, and Identity.

5. Benchmarking & Governance

- Established a quarterly KPI review cycle comparing Secure Score against industry benchmarks.
- Implemented a governance model to ensure sustained performance and accountability.
